(b) Application must be accompanied by :

(i) Age Certificate, (ii) Leaving Certificate from the School, College, Institute or the Board last attended, (iii) Attested copies of marksheets of all previous public examinations, (iv) Certificate from a respectable person who knows the candidate personally certifying his/her character, (v) Pass certificates of all previous public examinations, (vi) Migration Certificate (where applicable), (vii) *Income Certificate.

The application will not be entertained if the above enclosures are not attached with it. However, if the pass certificate of the previous examination and the Migration Certificate can not be produced at the time of admission due to non-availability, the same must be produced within THREE MONTHS from the date of admission, otherwise the admission will be treated as cancelled.
