Opening remarks of the Chairman:

The Vice-Chancellor, Prof. Bidyut Chakraborty welcomes the members and acknowledges that the Research Board meeting is being held after a long gap of fifteen months.

Confirmation of Minutes:

The minutes of the meeting of the last Research Board held on 14.12.2017 were read and confirmed.

2. Registration of Ph.D. Students:

The Research Board noted the details of Ph.D. students who have not yet completed the course work & considered the applications for Registration in Ph.D. Programmes those who have completed their coursework are given in **Appendix-A**, **Annexure-I & Annexure-II**, respectively along with the observations of Research Board against each. Total number of **444** (136 + 308) applications have been approved, some of which with minor modification subject to necessary changes according to suggestion of Research Board as mentioned in remarks column. Rest of the applications have been referred back to the concerned BOS either for justification or revision of titles or status of supervision.

3. Re-registration of Ph.D. studentships:

Considered **33** no of application for Re-registration of Ph.D. students, duly recommended by the respective Board of Studies, regarding re-registration of Ph.D. studentships as indicated in **Appendix-B** which are **approved** by the Research Board.

4. <u>Cancellation of Ph.D. studentships</u>:

Considered 17 no of applications for cancellation of Ph.D. studentships, duly recommended by the respective Board of Studies as indicated in Appendix-C

The Research Board has approved cancellation issues.

5. Modification of the title of thesis of Ph.D. student:

Considered **14** no of applications for modification of the title of the thesis of Ph.D. has been approved by the Research Board as indicated in **Appendix-D**.

6. Change of status of Ph.D. studentship:

Considered the recommendation of the concerned Board of Studies for changing the status of 14 Ph.D. students, as indicated in Appendix-E.

It was RESOLVED that the change of status of Ph.D. students be accepted and acted upon.

7. Change of Supervisor/Joint Supervisor of Ph.D. student:

Considered the recommendations on **15 applications** of the concerned Board of Studies for Change of Supervisor/Joint Supervisor of Ph.D. student, as indicated in **Appendix-F.**

The Research Board has **RESOLVED** that the recommendations on **15 applications** of the concerned Board of Studies for Change of Supervisor/Joint Supervisor of Ph.D. student, as indicated in **Appendix-F are approved**.

8. Change of Thesis Language of Ph.D Students

Considered the recommendations on **03 applications** of the concerned Board of Studies for Change of Thesis Language of Ph.D. student, as indicated in **Appendix-G**. The Research Board has approved the **03** nos. Ph.D Students for changing their Thesis Language as recommended by the concerned BOS.

9. Research Board has consider and approve the actions taken by the Chairman, in respect of Registration of 11 scholars, Modification of title of theses of 81 Ph.D. Scholars, Re-registration of 108 Ph.D. scholars, Cancellation of 09 Ph.D. scholars, Change of Thesis language of 01 Ph.D. scholars, Change of Status of 09 Ph.D. scholars, Change of Supervisor/Joint Supervisor of 06 Ph.D. scholars as at Appendix-H.

10. D.Litt. / D.Sc. applications submitted by three candidates.

- (i) Dr. Biswadeb Chatterjee, School Bagan, Bolpur, Birbhum.
- (ii) Dr. Goutam Brahmachari, Dinendrapalli, Simantapalli, Santiniketan, Birbhum
- (iii) Dr. Brajagopal Majumder, Pyaribabu Bagan (West Joynagar), Agartala, West Tripura.

In respect of SI. No. (i) and (ii) one of the three experts did not recommend the synopsis submitted by the applicants for award of D.Litt./D.Sc. Degree of the University. After considering the reports of the experts and the relevant clause (2) of the D.Litt/D.Sc ordinance of the University, it was RESOLVED that since the two experts have accepted the synopsis and one expert did not recommend the synopsis in both cases of SI No. (i) and (ii), the synopsis be sent to another expert for opinion.

In respect of SI no. (iii) The Department of Physics, Siksha-Bhavana expressed the opinion that the subject/title of the synopsis has no relation with the Department of Physics. Accordingly, his application was not favourably considered.

11. Applications of Ph.D. students for exemption from Ph.D. Course-Work (who have already completed M.Phil).

It was RESOLVED that Ph.D. students, who have already completed M.Phil from Visva-Bharati or, other Universities / Institutions, will be exempted for the Ph.D Coursework.

12. <u>Application of some faculties (whose service has not yet confirmed) to get Ph.D. student to supervise.</u>

It was RESOLVED that the appeal of the faculties (whose service has not yet confirmed) to get Ph.D student to supervise was not accepted.

13. Applications of Ph.D awardee candidates seeking permission for publication of their thesis.

It was RESOLVED that the prayer of the Ph.D. awardees seeking permission for publication of their thesis be permitted.

14. Transfer of five Research Scholar from Vinaya Bhavana to Vidya Bhavana.

It is Resolved that the proposal for transferring of five research scholars in Education from Vinaya Bhavana to Vidya Bhavana be permitted consequent upon transfer of the concerned faculties.

15. Miscellaneous Items:

- a. Major revision of a thesis The matter was considered and it was RESOLVED that as per Ordinance the candidate, Smt. Sampa Das, Dept. of Anthropology will resubmit her thesis after major revision and the re-submitted thesis be evaluated by the same examiner who evaluated the thesis.
- b. Seeking extra time to submit a thesis beyond re-registration period After discussion it was RESOLVED that the prayer of Siraj Monir, Dept. of Plant Protection be not granted.

The meeting ended with a vote of thanks to the Chair.
