### **ADMISSION TO TWO YEAR CERTIFICATE COURSE, SANGIT-BAHVANA**

Applications in prescribed form are invited for Admission to Two Year Certificate Course for the year of 2018-2019.

- Prescribed application forms may be obtained from Sangit-Bhavana Office on production of a Cash Coupon (Rs. 500/- for General/OBC candidates and Rs.150/- for SC/ST/PWD) candidates to be procured from the Accounts Office, Visva-Bharati.

Applications forms may also be downloaded from the University website ([www.visva-bharati.ac.in](http://www.visva-bharati.ac.in)) and in such case, a Demand Draft of Rs. 500/- for General/OBC candidates and Rs. 150/- for SC/ST/PWD candidates issued in favour of "ACCOUNTS OFFICER, VISVA-BHARATI" drawn on State Bank of India, Santiniketan (Code: 2121) must be attached with the filled-up application form.

The candidates should attach self-attested photocopies of (i) Marksheets & Certificates of all previous public examinations, (ii) Birth certificate, (iii) Proof of residence, (iv) Caste certificate, (v) PWD certificate, (vi) Family Income certificate, (vii) Two passport-size recent photo of the candidate.

- Period of issuance of form: **1<sup>st</sup> September, 2018 (Saturday)**.
- The form duly filled up with necessary enclosures should be submitted to the office of the Principal, Sangit-Bhavana. **The last date of submission of completed form is 25<sup>th</sup> September, 2018 (Tuesday) up to 4:00 P.M.**
- Date of Admission Test: **9<sup>th</sup> October, 2019 (Tuesday) at 9:00 A.M.**
- Venue of Admission Test: **Sangit-Bhavana, Visva-Bharati.**

**SUBJECTS: (1) RABINDRA SANGIT, (2) MANIPURI DANCE, (3) KATHAKALI DANCE, (4) RABINDRA NRITYA, (5) HINDUSTANI CLASSICAL MUSIC (VOCAL), (6) SITAR, (7) ESRAJ & (8) TABLA.**

**Note: Those who have applied earlier in 2018 through online mode need not apply again. Their applications will also be considered, subject to satisfying prescribed conditions of eligibility. No call letter will be issued for this purpose.**


Since the Two Year Certificate Course is a Part-time Casual Course, students admitted to such course shall be treated as “CASUAL STUDENTS”. They will be entitled to restricted Library facility and they shall not enjoy other facilities normally extended to the regular full-time students of this University. A regular full-time student, opting for a part-time Music & Dance Course, also will not be entitled to extra library facility.

**Eligibility: (1) Madhyamik or passed equivalent examination.  
(2) Staff and Students of Visva-Bharati.**

Those candidates who are not the staff and students of Visva-Bharati applying for admission must produce a Certificate from the Chairman of the Municipality, Pradhan of the Gram Panchayet together with other residential proof\*like Voter Identity Card/Aadhaar Card, Electricity Bill and Driving License etc.
