### **About Visva-Bharati:**

Founded by the first non-European Nobel Laureate Rabindranath Thakur (popularly known as Tagore) in 1921, Visva-Bharati was declared a central university and an institution of national importance by an Act of Parliament in 1951. The President of India is the Paridarsaka (the Visitor) of the University, the Prime Minister of India acts as the Acharya (the Chancellor), and the Governor of West Bengal is the Pradhana (the Rector).

### **About the Department of Lifelong Learning and Extension:**

Department of Lifelong Learning and Extension (Rural Extension Centre) is one of the oldest departments under Visva-Bharati. It has been actively improving the villagers' condition since the inception of the Sriniketan Experiment (1922). Over the years the department has been giving emphasis to extension and mass education programmes to encourage the villagers to become self-reliant. From its inception, the department has been advocating for the cooperative way of living with integration, local initiatives, local leadership, and local self-governance in every aspect of public life as envisaged by Gurudev Rabindranath Tagore. Considering the growing demands of society, the Department of Lifelong Learning and Extension (REC) also spread its area of work. Presently, the department provides extension and field outreach services to 65 villages scattered in two Community Development Blocks and under eight Gram Panchayats for holistic development. During the convocation lecture on 25th May 2018, our Hon'ble Acharya (Chancellor) and Prime Minister of India, Sri Narendra Modi appreciated the initiators, being informed regarding the development works carried out in the surrounding villages through Visva-Bharati. In his address, he extended hope and expectation that the university seeks to reach the initiatives in 100 villages by 2020-2021, celebrating the completion of 100 years of the University as well as the Sriniketan experiment.

### **About the Foundation of Practising Geographers, Kolkata:**

The foundation of Practising Geographers, a registered scientific body under the West Bengal Societies Registration Act of 1961, formerly known as the Indian Geographical Foundation, was established by Dr Arun Kumar Singh, Dr Ashoke Kumar Sen, and Professor Arabinda Biswas in the year 1964. Its basic aim is to promote scientific research, training, and publication in the field of Geography and allied disciplines like Anthropology, Sociology, History, Development Economics, Rural Studies, and Environmental science. It focuses on research around the marginal regions and their people and tries to understand the mechanism of the man-environment relationship. It has been publishing a well-acclaimed journal named 'Practising Geographers' and has credit for publishing several books like Environment and Health Frontier Ahead, Decoding Geography, Dreaming Geography, and Socio-Economic Environment of the Tribes of India.

It has organised several National and International Seminars of its own and also in collaboration with the Department of Geography, Visva Bharati, in 2010 and 2014, the Department of

Geography, Aliah University, in the year 2019, Department of Geography, Admas University, in the year 2022 and with the Department of Geography Cooch Behar Panchanan Barma University in 2023.
