
Dear Sir/Madam,

Please find enclosed herewith a copy of the Order No. 20-5/2014/EE.17 dated 28<sup>th</sup> May, 2015 of **Rashtiya Avishkar Abhiyan**, a scheme initiated by Department of School Education & Literacy. Under the scheme, higher education institutions have been involved to mentor neighbourhood higher secondary, secondary and upper primary schools for a period of 5 years. They will be called 'Mentoring institutions'. As per the order, the intervention of Department of Higher Education has been sought on the following:

1. Mentoring of Teachers by Higher Education Institutions (HEI)
  2. Mentoring by HEI of school science facility
  3. Mentoring of students by HEI and Graduate students at school
  4. Internship of students at Mentoring Institutions (HEI)
2. Under the heading Milestones for RAA initiatives, timelines have been specified in the said order, along with categories of mentoring institutions, specific areas for mentoring and number of schools to be taken up, beginning from the year 2015-16 to 2019-20.
3. Further, a Conference on the subject is likely to be organized shortly where institutions would have to present their plan for the programme.
4. I shall be grateful, if you could kindly send your draft plan accordingly ( as said in para 2 above) by 23<sup>rd</sup> June, 2015 positively.
