| g. Outsider except University Guest | : Rs. 150/- Per Slot |
| h. Academic Classes of V.B only from Bhavanas / Department
(Upto 50 heads in a group with at list one faculty members) | : Rs. 800/- Per Slot |
| i. Sports Club for any team not more than 30 heads | : Rs. 2000/- Per Slot |
| j. Member of the Swimming Pool management Committee | : Rs. 1000/- per year |

N.B. Interested Educational Organisation (not more than 50 heads per slot) may be allowed 2 days per week against fees.

Processing fees and cost of user pass: An amount of Rs.200/- will be charged as processing fees and cost of user pass.

The prescribed Application Form is to be downloaded from the University Website. Each applicant shall apply in separate Application Form. The filled in Application Form has to be submitted with supported documents as mentioned in the Application Form at the Swimming Pool Counter (Except Friday)

Upon approval of the field in Application Form by the Swimming Pool Management Committee the fees will be deposited to the Sports Board Counter located at Swimming Pool from 7:00a.m. to 9:30 a.m. and 4:00 p.m. to 6:00 p.m. on Monday, Tuesday, Wednesday, Thursday, Saturday and Sunday except Holidays. On depositing the Fees, User Pass will be issued.
