The Quote should be given on the basis of yearly premium for each student. The Total strength of student is approx. 7,210 including school students and Research Scholars as per last year academic session. The strength may increase in the next academic year. The tailormade policy should cover the following features:-

- 1. Covering maximum reimbursement amount for the hospital expenses of the student. This should be applicable to any other hospital which is not included in the TPA list. Pearson Memorial Hospital of the University should also be covered in the TPA list. Minimum amount is Rs.50,000.00 per year.
- 2. Cashless treatment facility for pre/post hospitalization of the student all over India. Pre Hospitalization should include relevant medical expenses incurred during period up to 30 days prior to hospitalization on disease/illness/injury sustained will be considered as part of claim.
