

This is in continuation of this office letter No.F.42-1/2012(CU) dated 1<sup>st</sup> October, 2013 (copy enclosed) in which UGC had asked the Registrar of all Central Universities to advise all their Departments / Centres that no request should be sent to UGC for financial assistance for organizing National / International conferences/seminars/symposia/workshops etc., as it is now a part of the XII Plan General Development Assistance and such proposals may be considered by the Universities at their level within the XII Plan General Development Allocation.

It has been observed that inspite of UGC instructions and clear mention in this regard in the guidelines meant for XII Plan General Development Assistance, the Central Universities or their Departments / Centres are frequently sending their requests to UGC for financial assistance to organize such events. I am, therefore, to request you again to issue appropriate instructions to the Departments / Centres/ Schools of your University not to send such request to UGC and approach the competent university authorities in this regard.
