OFFICE ORDER

The undersigned is directed to convey that the Karma-Samiti (Executive Council) at its meeting held on 24.01.2015 vide Resolution No.8, considered the legal opinion given by Shri Srenik Singhvi, Retained Lawyer, to the effect that the prayer of Visva-Bharati University Faculty Association (VBUFA) for issuance of "No Objection Certificate (NOC)" can not be acceded to and it was resolved that the University shall adhere to the decision of the Karma-Samiti vide its meeting held on 28.03.2009 which stands, superceding all its earlier decisions/resolutions.


The text of the Karma-Samiti Resolution dated 28.03.2009 is reproduced here below for clarity:

"The Vice-Chancellor reported that he had received a written representation from the Visva-Bharati Adhikarik Sabha (Visva-Bharati Officers' Association). The Visva-Bharati Adhikarik Sabha (Visva-Bharati Officers' Association) has requested to grant formal recognition to their Association. It was stated further that these are voluntary associations amongst employees of the Visva-Bharati. These are not Statutory bodies. Among them are to be counted the Karmi Sabha, the Adhyapaka Sabha and Officers' Association and as far as Visva-Bharati is concerned, they may stand on par. The Vice-Chancellor sought the opinion from the Executive Council in respect of granting formal recognition to the Visva-Bharati Adhikarik Sabha (Visva-Bharati Officers' Association). The Executive Council thus Resolved that the above employees of the University have the right to form Association and the Visva-Bharati Adhikarik Sabha (Visva-Bharati Officers' Association) stand at par with similar voluntary associations in Visva-Bharati."

Therefore, the said Adhyapaka Sabha, Karmi Sabha, Adhikarik Sabha, Visva-Bharati University Faculty Association (VBUFA) and similar associations that may be formed in the future, are to be regarded as voluntary associations.
