

Subject:-Regarding registration of all NGOs on Darpan Portal.

Sir/Madam,

A meeting of Group of Officers was held on 30th May, 2017, under the Chairmanship of CEO, NITI Aayog, to discuss issues relating to NGO-Darpan Portal. Attention is invited to the following decisions taken in the meeting:-

- i) No financial grants shall be disbursed to the NGOs during the current financial year without obtaining a Unique I.D. generated from the NGO Darpan Portal.
- ii) All Ministries/Department have to process the application of NGOs for release of grants only in 'online mode' and there shall be no manual processing of applications.

2. In view of the above, the Vice-Chancellors of all Central Universities may ensure that before disbursement of any financial grant to the NGOs, the NGOs may be directed to compulsorily register under the NGO Darpan Portal for obtaining a Unique ID. Henceforth, it may be ensured that processing of applications for release of grants to the NGOs may be done only in online mode and no manual processing of applications may be entertained. The Vice-Chancellors of all Central Universities are also directed to develop their portal with the help of NIC so as to enable submission of NGO applications online.
