This is regarding conducting of All India Pre-Veterinary Test -2015 for filling up 15% of All India Quota seats in the Veterinary Colleges in India (except from Jammu & Kashmir State).

The Veterinary Council of India is a statutory body established under Indian Veterinary Council Act, 1984 (52 of 1984) and charged with the responsibilities of regulation of Veterinary practice, preparation and maintenance of Indian Veterinary Practitioner's Register, regulation of minimum standards of Veterinary education and matters connected therewith.

The Veterinary Council of India in exercise of the powers conferred by sub-section (1) of section 22 read with clause (b) of sub-section (1) of section 21 of the Indian Veterinary Council Act, 1984, with the prior approval of the Central Government has framed Minimum Standards of Veterinary Education - Degree Course (B.V.Sc. & A.H.) Regulations, 2008. Regulation 7(7) of the said Regulations, provides that 15% of the total number of seats of each veterinary college shall be reserved to be filled upon All India basis through Common Entrance Examination (All India Pre-Veterinary Test) to be conducted by Veterinary Council of India.

In view of the above, I would like to inform that the Council as per the provisions of the said Regulations shall conduct the AIPVT - 2015 for the academic session 2015-16 on Saturday, the 20th June, 2015 (2 to 5 P.M.) at different Centres throughout the country. The detailed Notification containing the eligibility criteria, age, and last date of On-line Application Form etc will be issued in leading newspapers by 1st Week of April, 2015.

I, therefore, request you to kindly give wide publicity of the said Examination through the website of your esteemed organization/print media and local media for the awareness of the general public.
