Proof of such bank transaction and EPF and ESI submission should be submitted along with the monthly bill for reimbursement from the University.
- 4) The vehicles preferably supplied by the Agency itself. Necessary legal papers should be submitted to the office of Chief Security Officer.
- 5) In case of any accident / break down of vehicle, the entire responsibility of payment to the Third Party / Driver / Staff and Repair Cost will be borne by the Agency and no claim in this regard will be entertained by the University.
- 6) The drivers engaged in the vehicles should have valid commercial Driving Licenses and without any adverse Police record, free from any addiction to Drugs / Liquor, free from any contagious disease. Normally they should be allowed for eight (8) hours duty at a stretch. The drivers should remain clean in appearance and behave gently. They are to be covered by all Govt. rules and norms as applicable.
- 7) Payment will be made on monthly basis by the Accounts Officer, Visva-Bharati on submission of bill from the vehicle supplier through the Chief Security Officer.
- 8) In case of satisfactory performance the authority may renew the contract for the further period of another one year on the existing terms and conditions.
- 9) The vehicle should have valid permit for plying in Birbhum District and hold commercial number.
- 10) No demand for alteration of rate in connection with the fluctuation of market price for fuel/lubricant will be entertained by the University during the period of engagement.
- 11) Selected Party has to sign a formal agreement with the University covering the above said points at its own cost within seven days from the date of work order.
- 12) Vendors are requested to quote their hiring rates for 24 hours basis in a prescribe format of the CPP Portal in BOQ for formation as design by Central Purchase Section within 11/02/2019 at 1200 hrs. Tender opening date is 12/02/2019 at 1530 hrs.
