NOTICE

In compliance to the guideline of NEP 2020, all the students from Four Years Undergraduate (FYUG) Programme of NEP must complete one internship programme of 4 credits (minimum 120 hrs.) before completion of Four Years Undergraduate Programme. Every Department is, therefore, requested to submit the list of internship programmes to be provided to students for ongoing as well as upcoming Academic Session as University Internship Providing Organization (UIPO). The format for submission of such programmes is attached herewith as Annexure-I.

All the Departments are also requested to go through the Guideline to conduct Internship programme and assessment for all UG Programmes as per NEP-2020 published by Academic & Research on 09/01/2025. The guideline is attached as Annexure-II.

Further, it is also notified to all the Departments of Visva-Bharati that a list of 15 (Fifteen) "Open Call Internship" programmes has been prepared where the students of Four Year Undergraduate Programme can enrol as internee to fulfil the requirement of the credits for exiting the FYUG programmes or completion of the FYUG programme.

All the Departments are requested to identify and assist students to select an appropriate internship programme with minimum 120 hours of work from the above online internship providers.

This is further clarified that for any Government certified Organization/Institution inviting internship applications through open advertisements, it is not necessary for the Department to sign MoU with such Organization/Institution. However, the Department has to identify such Organization/Institution and encourage students to enrol in such Organization/Institution.

Students are advised to consult with the Internship Supervisor of the Department before enrolling themselves in any Internship Programme from these internship organizations. The internship programme opted by the students must fulfil the minimum criteria mentioned in the NEP curriculum and follow the General Instructions mentioned in the Guideline (attached as Annexure-II) to conduct Internship programme and assessment for all UG Programmes as per NEP-2020.

Students can also register in any Government certified Organization/Institution for internship through BOS of the Department. However, such Organizations/Institution should be listed in the Departmental list as internship providing Organization.

As an initiative from Academic & Research, Visva-Bharati, all the students from Semester 2 and Semester 4 of Four Year Undergraduate Programme of Visva-Bharati have been registered and login accounts have been created in the "Internshala" (https://internshala.com/internships) platform through SAMARTH Portal. Students may receive an email inviting them from student@internshala.com inviting to log into the Internshala portal.

sted students may register for Internship courses offered through Internshala to acquire 4 its equivalent to 120 hours of engagement. Students are advised to consult with the ternship Supervisor of the Department before enrolling themselves in any internship programme in Internshala.
