Scholars stress need for upholding Netaji's ideals of unity, secularism

KOLKATA, JAN 24/--/ Eminent scholars here paid rich tributes to Netaji Subhas Chandra Bose on Monday, on the occasion of his 126th birth anniversary, noting that it was necessary to uphold the freedom fighter's ideals of unity and secularism to honour his legacy.

Literary theorist and Padma Bhushan recipient Gayatri Chakravorty Spivak told PTI, on the sidelines of a programme at Netaji Research Bureau, that "a strong tradition of unity" still prevails, despite the existence of a "divisive culture", and that is the most "comforting thought".

People of different communities have been "living side by side for centuries". There can be conflicts at times but they tide over those differences for peaceful co-existence, the academic said.

Asked if the values and ideals cherished by Netaji are currently under threat, Spivak said an academic like her should look forward to the day

when his dreams are realised.

"The ideals of Netaji will be realised when we listen to electorate living at the bottom rung of societies, understand their words, the people who cast votes," she said.

Ismat Mehdi, the niece of Netaji's close aide and INA warrior Abid Hasan, said a significant part of the present generation has little idea about INA fighters who sacrificed everything for the country. People currently are reaping the benefits of their sacrifices, she said.

Mehdi called for inclusion of INA's contributions in school curriculums.

"Netaji had united all sections of society, from north to south and east to west. His INA had endorsed all colours... His Constitution (for Inde-

Cal HC sets aside ban on use of hookahs in bars & restaurants in Kolkata & Salt Lake

KOLKATA, JAN 24/--/ The Calcutta High Court on Tuesday set aside a ban on the use of hookahs in bars and restaurants in Kolkata and adjoining Bidhannagar (Salt Lake) imposed by the civic authorities in the two cities.

The National Restaurant Association of India moved the high court claiming that such restaurants and bars in the two cities have not violated any provisions of the Cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003, of the Central government.

Noting that the West Bengal government has not framed any rules in this regard, Justice Rajasekhar

Mantha observed that in the absence of any rules, the municipal corporations of Kolkata and Bidhannagar cannot pass orders against use of hookahs in bars and restaurants having a valid licence.

The court held that the restaurants and bars do not need a separate trade licence for the use of hookahs there.

"Any direction contrary to the above, issued by the Kolkata Municipal Corporation or the Bidhannagar Municipal Corporation is illegal and bad in law," the court held.

Justice Mantha said that these establishments are, however, required to strictly comply with the provisions of the COTP Act 2003.

TMC MLA faces protest during 'Didir Doot' programme in Birbhum village

KOLKATA, JAN 24/--/ Trinamool Congress MLA Ashis Banerjee faced protests on Tuesday as he went on a visit to a village in Birbhum district as part of the ruling party's programme 'Didir Doot' (Mamata Banerjee's messenger) to connect with the people before this year's panchayat elections in West Bengal. The Rampurhat MLA was confronted by some people claiming to be residents of the Mohammad Bazar area.

Claiming that he was not seen for a long time, the villagers at Mohammad Bazar area termed him as a "comet", a celestial object seen after long intervals of years. They alleged that no work has been done to repair roads in the area, which have been in bad shape for years. The TMC leadership have formulated the 'Didir Doot' programme for interaction between the party leaders and the villagers. Ashis Banerjee later said that he is visiting the villages as part of the programme so as to know about the complaints of the people and to communicate this to the proper authorities for mitigation. TMC leaders, including ministers, MPs and MLAs have been confronted with protests and complaints against panchayat leaderships, mostly belonging to the ruling party, during their visits to the rural areas of the state in the run up to the local body elections. They have faced complaints ranging from panchayat pradhans and members not working to that of alleged corruption and absence of leadership from the area. (PTI)

Kushwaha alleges "conspiracy" on to weaken Nitish; gets rebuffed

PATNA, JAN 24/--/ JD(U)'s sulking parliamentary board chief Upendra Kushwaha on Tuesday alleged that he was being undermined within the party as part of a "conspiracy" to "politically weaken" his mentor Chief Minister Nitish Kumar.

Talking to reporters here, the former Union minister, whose recent meeting with BJP leaders in Delhi has raised many eyebrows, said he was ready to clear the air if given an opportunity.

"Nitish Kumar can summon me for an explanation. A meeting of the party can also be convened. But I will keep raising my voice against any attempts to weaken the chief minister", said Kushwaha.

He expressed anguish over being "kept out of party functions", like celebration of birth anniversary of former chief minister and socialist leader Karpori Thakur. "No one else in the party has taken on detractors indulging in diatribes against Nitish Kumar like I have", said Kushwaha claiming that but for his vehement protests, ally RJD would not have issued a show cause notice to its MLA Sudhaker Singh who remains in news for caustic attacks on the CM. He also alleged that RJD has been "officially stating that it had stuck a deal with our party at the time of the formation of the
