Research

In all my research studies I have tried to assess the impact of different developmental, policy and research interventions on rural peoples or rural livelihoods.

- For the first time in India, developed a state wise time series data on private investment in agriculture & estimated state-wise and FYP-wise ICOR for Agriculture Sector in India
- Developed a new series on public investment in agriculture with wider coverage as compared to the existing narrow series developed by the CSO. The new series was used by Planning Commission (X Plan) and in Millennium Development Goal (MDG) by IFPRI, Washington. The work was recognised by the Planning Commission; Indian Agricultural Research Institute (ICAR), New Delhi and Indian Society of Agricultural Economics (ISAE), Mumbai in terms of awards and felicitations.
- The author has also developed an interactive policy dialog model (based on PODIUM model of IWMI, Colombo) to assess the water and food security scenarios at agro-ecological region level in India.
