# M. Phil ADMISSION 2014

Applications are invited for admission to two year M. Phil. Course in Sangit-Bhavana for the academic session 2014-15.

# 1. Eligibility criteria for admission to M. Phil. Programme:

# i) General and O.B.C Candidates:

The candidates who secured 55% marks in aggregate in the subjects / allied subjects / and or any other subjects at the Post Graduate Level with Music studied as an interdisciplinary subject at any level from any University/ Institution recognized by U.G.C preceded by Honours Degree in the same/ allied subjects/ and or any other subjects are eligible to apply for M. Phil. Course. The candidates with M. Mus. Degree from Open Universities and Correspondence Courses having Honours in B. Mus. and recognized by U.G.C. are eligible to apply for admission to M. Phil. Course subject to the fulfilment of the eligibility criteria. Candidates from any other discipline with adequate knowledge in Music may also apply.

# ii) For S.C / S.T / P.W.D. Candidates:

The eligibility criteria for admission to M. Phil. Programme is 50% marks in aggregate at the Post Graduate Level in the subject concerned / allied subject and or any other subjects at the Post Graduate Level with Music studied as an interdisciplinary subject at any level from any University / Institutions recognized by U.G.C.

#### 2. The following subjects are offered:

# i) Department of Rabindra Music, Dance & Drama -

- a. Rabindra Sangit, d. Rabindranritya and
- b. Manipuri Dance, e. Drama and Theatre Arts
- c. Kathakali Dance,

# ii) Department of Hindusthani Classical Music -

- a. Hindusthani Music (Vocal),
- c. Esraj and other bowing and wind Instruments, d. Tabla and f. Pakhawaj.
- b. Sitar and other plucked Instruments,

# 3. <u>Admission procedure</u>:

Admission Test of 100 Marks will be conducted in two parts - (i) Written Test of 50 Marks and (ii) Practical Test of 50 Marks.

The written test will be held on 11<sup>th</sup> August 2014 at 10 a.m. It will be of two hours duration. The students, who will qualify the written test, will be called for practical admission test which will be held on 18<sup>th</sup> August 2014 at 10.00 a.m.

- a. The candidates who will attain pass marks in the Group-'B' section of written test (subjective broad questions) will be called for the practical test.
- b. The pass marks in the group-'B' section is 50% for the general and OBC candidates, and 30% for the SC and ST candidates (i.e. 10 out of 20 for general and OBC candidates and 06 out of 20 for SC and ST candidates).
- c. At the time of preparing final merit list of qualified candidates, results of both the 'A' and 'B' groups of written test and the practical test will be taken together.
- d. Final qualifying marks will be as follows :
  - i. General and OBC-50 out of 100.
  - ii. SC and ST-30 out of 100.

- e. Out of 50 Marks of Written Test, 30 Marks will be of Objective type (Gr.-A) and 20 Marks will be of Subjective/Descriptive type (Gr.-B). Out of 20 Marks of Subjective/ Descriptive nature, there will be two compulsory questions of 10 Marks each.
- f. Candidates who will secure at least 4(four) Marks out of 10 Marks in each Subjective/ Descriptive compulsory question, i.e., 4 qualifying marks in compulsory question, will be called for Practical Examination.
- g. The minimum pass marks for General Candidates and Candidates under Reserved Category are 50 out of 100 and 30 out of 100 respectively.
- h. Preference will be given to U.G.C / J.R.F Certificate holders. No provisional admission will be allowed,
- i. The merit list will be prepared on the marks of the Admission Test out of 100.
- j. The final result of M. Phil admission test of Sangit-Bhavana will be published in Visva-Bharati websites.
- k. It may further be noted that M. Phil. Course of Sangit-Bhavana is a full time course of two years and therefore, the qualified candidates are to attend classes regularly.
