PROGRAMME:

Sabar Translation Workshop at Granthana Vibhaga

19-20 January 2015, Kolkata

A two-day Sabar Workshop for translating of Tagore's *Gitanjali* into Sabar language, was held at

the Sabhaghar of the Visva-Bharati Granthana Vibhaga, Kolkata, on 19-20 January 2015.

The translators in the workshop were Sri Prasanta Rakshit from Purulia town, Sri Fatik

Kumar Hembram from Salidi village of Bundwan P.S. of Purulia, Sri Jaladhar Sabar of Kuda

village of Kenda P.S. of Purulia and Sri Bholanath Sabar of Radhanagar village of Bundwan

P.S. of Purulia.

At the beginning Sri Debasish Roy sang the Rabindrasangit 'Amare tumi asesh korecho

emani lila taba'. The workshop started with an Introductory Speech by Dr Ramkumar

Mukhopadhyay, Director, Visva-Bharati Granthana Vibhaga.

Dr Mukhopadhyay, in his speech, said that the book Gitanjali was taken for translation into a

number of tribal languages to mark the centenary of the presentation of the Nobel Prize to

Tagore and Sabar was one of them. Sabar, he mentioned, is a tribe which was denotified by the

British government. After the independence of the country it was accommodated in the

mainstream.

Sri Prasanta Rakshit, Director of the workshop, said that Sabar tribe has a rich oral tradition. For

the lack of proper patronage, the language of about 12,700 people alone in Purulia is on the

way of extinction. He highlighted the role of the tribe in the freedom movement. About 196

Sabar people fought against the British in 1947 but only two among them were recognized as

freedom fighters others were treated as dacoits, he deplored.

Sri Jaladhar Sabar sang the Sabar version of the song number 102 from Gitanjali --- Tahar

sonar tare saj amar dukhar sudha janani go (Bengali:Tomar sonar thalai sajab aj).

Sri Ramaprasad Deb sang the closing song 'Tumi ektu kebal boste dio aj'.

The final version of the manuscript is expected to be received in March 2015.

### Symposium on 'Rabindra Sristite Nari' at the Kolkata Book-fair

#### 30 January 2015

Visva-Bharati Granthana Vibhaga in collaboration with Publishers and Book Sellers Guild organized a symposium on 'Rabindra Srishtite Nari' at the Kolkata Book-fair on 30 January 2015.

Dr Ramkumar Mukhopadhyay, Director, Visva-Bharati Granthana Vibhaga in his welcome speech, discussed how in Tagore's creations – poetry, fiction, plays, paintings, etc – the woman characters play a significant role and sometimes a central one also. He introduced the guests and speakers. Professor Sushanta Dattagupta, Hon'ble Vice-Chancellor, Visva-Bharati, remarked that the theme was appealing. He mentioned that Tagore entered into the inner world of women – her emotions, agony, sorrow, happiness, emancipation, freedom of thoughts. Fictional characters like Charulata can be cited as an example. He spoke about psychoanalyst Sri Sudhir Kakkar, who has made a significant study of Tagore's portraits depicting the woman.

Smt Swagatalakshmi Dasgupta picturised three women characters from Tagore's dance-dramas, namely *Shyama*, *Chitrangada* and *Chandalika*. Shyama takes the path of lie to get her beloved but truth wins and the drama ends in tragedy. Chitrangada also walks in the path of deceit to get her beloved Arjuna but finally she reveals the truth and the drama has a happy ending. Chandalika is an allegorical character who is a symbol of innocence. Love comes in the form of honour to her. Love bestows upon her by the character Ananda is a form of respect. This love ultimately satisfies her soul. Smt Swagatalakshmi Dasgupta enriched her speech with Rabindrasangeet.

Prof Aparna Roy selected *Mohua* book of poems where Tagore describes seven women viz, Shyamali, Kajali, Sagari, Heyali,Kakali, Jhamuri and Krishnakali. These women characters mark their prominence through their daily household chores. It is revealed in the poem 'Aobhan' that a man needs a woman in every sphere of his life. In the poem 'Jayati' she emerges as a winner. Honour and respect for women is showered in the canvas of *Mohua*.

Sri Tridib Chattopadhyay, Secretary, Publishers and Book Sellers Guild found the topic important, particularly when the gender-issue is a major topic of discussion now. He thanked all the speakers and the audience for making the programme successful.
