Criteria of eligibility for submission of bid documents:

Tender papers will be sold to the intending bidders on certification from the Competent Authority of the University, Visva-Bharati at Santiniketan against the application to be submitted by the contractor for purchase of tender paper in the prescribed form available from the office of the University Engineer / Professor-In-Charge. The Documentary evidence in support of the same should be submitted along with the application.

Intending bidders should have the experience of repair maintenance of Electrical Works in running hostels / quarters / office buildings and completed minimum value of work of total Rs.4,20,000.00 or 2 nos. work of each not less than Rs.3,50,000.00 in last three years in Govt., Semi Govt., Statutory and Autonomous Organization.

Process of evaluation and issue of work order:

- (a) Lowest (L1) qualified tender submitted for the job will be identified primarily. Other bidders sequentially from L2 will be offered to accept the lowest rate to work out a panel of Six (6) contractors with whom the University would enter into the rate contract with the terms and conditions stipulated in "**General Direction and Condition of Contract for works**". These agreements will remain valid for the work orders to be issued within the period of contract. The contract may be extended for a further period on mutual agreement of both the parties.
- (b) As and when required, work orders will be issued to the respective contractors mentioning the location, detail of work, schedule of work, cost and time of completion. All such work orders will be executed under the agreements mentioned above.
- (c) The approximate value mentioned above is tentative and the actual value of work will depend on the requirements of the University, fund availability and the performance of the individual contractor.
- (d) Earnest money deposit will be refunded to the Unsuccessful bidder in due course. For successful bidder this amount will be considered as the earnest money deposit for the subsequent Work Orders.

The time allowed for carrying out the work will be as specified in work orders.


Bidders must submit the copies of valid **GST registration, credential of satisfactory completion of work, Electrical licenses** as specified, along with the application. The originals of those are to be shown as required.

The applicant who will fulfill the stipulated conditions may obtain tender form together with (i) General Directions and Conditions of contract for works (ii) Standard Civil Engineering Specifications from the **office of the University Engineer/ Professor-In-Charge, Visva-Bharati, Santiniketan** on all working days (**except Saturday, Sunday & Other holidays**) on payment of the sum as shown against the work in the cash section.

All Tender documents should be deposited in the letterbox in the Central Purchase Section.

Cash section remains open from 10:00 am to 1:30 pm on all working days except Saturday, Sunday & other holidays.

Bidders may attend themselves or send their authorized representative at the time of opening of tenders. Tender will remain valid for 90 (ninety) days from the date of opening. Full particulars about the procedure for depositing earnest money will be available in the tender documents.
