- (2) The bidder shall have to serve proper hygenically cooked fresh quality meals. Cooking, packing and service of the meal should be done in hygenic conditions. The supply of meals will have to be made throughout the scientific event. Overall numbers of meals to be supplied will be approximately 1500-2000. However numbers of meals may increase or decrease.
- (3) Organisers will not provide utensils, water, any raw as well as serving materials and transportation to serve the food. Utensils and other servicing materials to serve the food will be brought by bidder and will take back after serving meals.
- (4) Table arrangement and lighting (in case of dinner) to be made by the bidder. The rate of bid in the above should be inclusive of all.
- (5) The Organizer reserves the right to accept/reject the lowest tender or all the tenders without assigning any reason. It is not necessary that contract will be alloted to all or any parties that participate in the tender.
- (6) Validity of the offer: The bidder shall have no right to revise the quote within the period of validity on the plea of fluctuations in the market rate. The validity of the offer should be for a specified period of 90 days.

- (7) The ST/VAT/IT Pan No. or Registration Number (as the case may be) should invariably be quoted in the offer, a photocopy of the latest clearance certificate of the above be enclosed with the offer, failing which the offer will not be considered.
- (8) The University does not take responsibility and liability of compensation for any accidental loss occurred during the event.
- (9)Suppliers having Rate Contract with Central or Provincial Government should quote along with a certified copy of the current Government Rate Contract.
- (10)All quotations should be net, after showing discounts, if any.
- (11) An amount of Rs. 500/- in the form of Demand Draft as non refundable application fee in favour of 'Accounts Officer, Visva Bharati' payable at State Bank of India, Santiniketan Branch must accompany the quotation.
