Bidders must submit the copies of valid **GST registration, credential of satisfactory completion of work, Electrical licenses** as specified, along with the application. The originals of those are to be shown as required.

The applicant who fulfills the stipulated conditions may obtain tender form together with (i) General Directions and Conditions of contract for works (ii) Standard Civil Engineering Specifications from the office of the University Engineer, Visva-Bharati, Santiniketan on all working days (except Saturday, Sunday & Other holidays) on payment of the sum as shown against the work in the cash section.

Cash section remains open from 10:00 am to 1:30 pm on all working days except Saturday, Sunday & other holidays.
