Sub: Coverage under Central Civil Service (Pension) Rules, in place of National Pension System (NPS), of those Central Government employees who were recruited against the posts/ vacancies advertised / notified for recruitment, on or before 22.12.2003-reg.

This is for information to all concerned that UGC vide its circular bearing F.No. 25/4-2007(CU)pt.file2 dated 06/07/2023 has forwarded a circular duly notified by Ministry of Personnel, Public Grievances and Pensions Government of India, bearing No. 57/05/2021-P&PW(B), dated 3rd March, 2023 regarding coverage under Central Civil Services (Pension) Rules, in place of National Pension System, of those Central Government employees who were recruited against the posts/ vacancies advertised/ notified for recruitment, on or before 21-12-2003 for implementation.

In terms of the above Circular of DOPT, all cases where the Central Government civil employees have been appointed against a post or vacancy which was advertised/ notified for recruitment/ appointment, prior to the date of notification for National Pension System (NPS) i.e 22.12.2003 and are covered under the NPS on joining service on or after 01.01.2004, are to be given a one-time option to be covered under the CCS (Pension) Rules, 1972 (now 2021). The Government servants who exercise option to switch over to the pension scheme under CCS (Pension) Rules 1972 (now 2021), shall be required to subscribe General Provident Fund (GPF). The account of the corpus in the NPS account of the Government servant shall be done as per instructions contained in the OM of DOPT dated 03.03.2023.

In view of the above, the following instructions are issued:-

- a) Those eligible Government servant, who are presently employed in Visva-Bharati and had joined posts in Visva-Bharati, for which such option is being exercised, and whose cases are to be considered by the Appointing Authority in Visva-Bharati, are instructed to submit their options in the **Annexure-I**.
- b) Those eligible Government servants, who had joined Visva-Bharati after Technical Resignation from other departments/offices and are presently employed in Visva-Bharati, but whose cases are to be considered by the Appointing Authority in their previous offices, are instructed to submit their option in **Annexure-II**, along with valid documentary proof, so that it may be forwarded to the concerned offices. If their past service has not been counted and regularized, request may be submitted for the same at the earliest.

- The option may be exercised by the concerned Government servants latest by 31.08.2023.
- Option once exercised shall be final.
- Those Government servants who are eligible to exercise option, but do not do so by the stipulated date, shall continue to be covered by the National Pension System.

It is emphasized that although the last date for submission of option is 31.08.2023, efforts may be made for early submission, so that the process may be completed by the due date i.e 31.10.2023.
