***The fulfillment of these conditions is to be certified by the Registrar or the Dean(Academic Affairs) of the University concerned.***

### **GENERAL CONDITIONS FOR THESE RECRUITMENTS :**

01. **"Good academic record"** shall mean "securing on an average, at least 55% marks in all examinations taken together prior to Master's degree viz Secondary (class X), Higher Secondary (10 + 2) or equivalent and Honours degree stage. However, 55% marks at Master's degree level are mandatory as per UGC norms".

02. Visva-Bharati reserves the right not to fill up the vacancies if circumstances so warrant and withdraw any advertised post(s) at any time without giving any reason.

03. The eligibility of an applicant shall be determined in accordance with the UGC Regulations, 2018 and its subsequent amendments from time to time.

04. Candidates must fulfill essential qualification / experience on the last date of application. All educational qualifications must have been obtained from recognized University / Institute only.

05. Essential qualification / experience prescribed are the minimum and mere possession of them will not entitle an applicant to be called in for interview.
