

- Parties has to enclose the following documents with the proposal:

  - Copy of previous year TAX return.
  - Copy of this Enquire Letter.
- Apart from other applications in respect of the quality, standard, terms etc., the offer should specially clarify the points noted below, in the following order:
  - Validity of offer*
  - Period of Delivery.*
  - Place of Delivery*
  - Central Sales Tax/VAT Sales Tax/Service Tax*
  - Excise Duty*
  - Insurance*
  - Packing and forwarding Charges and Freight*

The quotation shall have no right to revise them within the period given here on the plea of fluctuations in the marker rate. Normally the validity of the offer should be for a specified period of 90 days.
  - Time of Delivery:* - State the period during which the supplies will be effected by you in full.
  - Place of Delivery:* - Mention clearly the place of destination, and mode of transit by which the supplies will be affected without any extra charges. The University will prefer F.O.R. Sriniketan prices in case of outstation suppliers, and delivery at our site in case of local suppliers.
  - Central Sales Tax:* - State present rates leviable. In case the same is not applicable, mention 'Not applicable' and if the prices are inclusive of this sales tax, please write 'Included in the Prices'. The S.T./VAT/I.T. Pan no. or Registration No. (as the case may be) should invariably be quoted in the offer, a photo copy of the latest clearance certificate of the above be enclosed with the offer, failing which the offer will not be considered.
