In a meeting of the Principals of the Bhavana on 15.07.2017, chaired by the respected Vice-Chancellor regarding elligiblity criteria to appear at the Supplementary Examination 2017 were approved as follows.

- 1. Elligiblity criteria to appear at the Supplementary Examination 2017:
- The students who have appeared in Semester VI/VIII examinations (as the case may be) of Undergraduate courses in 2017 and got back in paper(s) in Semester-V/VII or Semester-VI/VIII (as the case may be) are elligible to appear at the said examination(s) in their back paper(s) like the previous year.
- The students who have appeared in Semester-IV examination of Post Graduate Course in 2017 and got back in paper(s) in Semester-III/IV are also elligible to appear at the said examination in their back paper(s).
- The students who have appeared in their final Under Graduate Semester examination in 2017 and got back in one paper only in semester-I/II/III/IV or V/VI (for 4 year course) are elligible to appear at the said examination in that particular one back paper only like the previous year.
- The students who have appeared in their final Post Graduate Semester examination in 2017 and got back in one paper only in semester-I/II are elligible to appear at the said examination in that particular one back paper only.
- 2. The students will have to fill up the Examination form (on line) and deposit examination fees for the Supplementary Examination 2017 from 29.07.2017 to 31.07.2017 (without late fee) and 01.08.2017 to 02.08.2017 (with late fee).

The students are required to enclose photo copies of the marksheet in which he/she got back in their semeter(s) along with the copy of the filled up Examination forms and submit the same to the Bhasha-Bhavana Office.

- 3. The schedule of Supplementary Examination 2017 will be notified later.
- 4. There shall be no re-evaluation of answerscripts of the Supplementary Examination 2017.
- 5. The Supplementary Examination will be counted as one of the permissible chances.

6. Seperate notification for Supplementary Examination 2017 for Vidya-Bhavana students will be issued later.
