## **NOTIFICATION**

## Sub.: Free Entry to Rabindra-Bhavana Museum & Uttarayana

This is to notify for information of all concerned that free visit to Rabindra-Bhavana Museum, Uttarayana, Archives and Rabindra-Bhavana Library of Visva-Bharati will be regulated in the following manner:

1. All visitors other than staff, students of the University and visitors to the offices of Rabindra-Bhavana will be required to pay requisite 'Entry Fee' to visit Rabindra- Bhavana Museum and Uttarayana complex.

2. Staff and students of Visva-Bharati are permitted to visit Rabindra-Bhavana Museum and Uttarayana by producing their 'Identity Cards' issued by the competent authority of the University.

3. Registered users of Rabindra-Bhavana Archives and Library are permitted to enter Uttarayana for the purpose of using the Archives and Library by producing identity cards issued by Rabindra-Bhavana and valid appointments issued by the Director/Special Officer: Rabindra-Bhavana.

4. Duly signed requests for any free special visit to the Museum of Rabindra-Bhavana in specific format will be acceptable if routed through the following authorities as follows:

a. SDO, Bolpur for special visits of State Government officials (including states other than West

b. Additional SP, Bolpur for special visits of police officials.

c. Range Officer, Bolpur for special visits of forest officials.

d. Additional District Judge for special visits of Judicial Officials.

e. All Principals of Visva-Bharati for special visits of any guests of Visva-Bharati.

f. PRO, Visva-Bharati for any Central Government officials/eminent individuals.

5. The Secretariat of Upacharya, Office of the Registrar, Director of Rabindra-Bhavana and the Special Officer may apply discretions in allowing/disallowing visitors to Uttarayana and the Rabindra-Bhavana Museum without entry fee in the interest of Rabindra-Bhavana and Visva-Bharati as and when required.

6. The University reserves the right to allow or reject any request for visit to Rabindra-Bhavana Museum and Uttarayana without entry fee at any point of time.
