- 1.1 This estimate mentioned above, however, is given merely as a rough guide. The estimated cost is exclusive of GST and Labour Welfare Cess which will be paid additional as applicable.
- 1.2 Criteria of eligibility for submission of bid documents :

Intending bidders are eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed works specified below. These should be certified by officers not below the rank of Executive Engineer or equivalent.

One similar work of value not less than **Rs. 17,99,975.00** completed in last 5 years ending previous **day of last date of submission of bids.**

2. Agreement shall be drawn with the successful bidders on prescribed Agreement Form. Bidders shall quote his rates as per various terms and conditions specified in the general directions and conditions of contract which will form part of the agreement.
3. The time allowed for carrying out the work will be as specified above from the date of start as defined in work order or from the first date of handing over of the site, whichever is later.
4. The site for the work is available.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen on this website.
6. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
7. ***Tender Fees and Earnest Money shall be payable online through the e-Procurement Portal of Ministry of Education.***

Copy of the certificate of work experience and other documents as specified in the tender shall be scanned and uploaded to the e-Tendering website within the period of bid submission. **However, certified copy of all the scanned and uploaded documents as specified shall have to be submitted physically by the lowest bidder in the office of University Engineer within a week of the date of opening of price bid.**
