**General Conditions**

1. The quotation rate must be as per page cost including GST, hard bound (for books), paperback with glossy paper (for dictionaries) delivery charges and other.
2. All the publication will be attractive with systematic formatting along with professional copy editing and error free proofing (Wherever it is applicable).
3. One sample copy of book needs to be enveloped with the tender to showcase the quality of the paper, size of the book as well as bindery which will be at par with our proposed publication.
4. Credentials (Publication Guild Registration and Subject Expertise) of publication house will be enveloped with at least 10 titles along with ISBN and name of writers during last five years.
5. Content pages (in Black & white) of books will be with 70 GSM and jacket with 170 GSM (colorful and hardbound) similar to cover page.
6. Content pages of dictionaries (colorful) will be with 70 GSM and jacket with 170 GSM (colorful).
7. Size for books will be standard near to 9.5 × 6.25 "while for dictionaries 5 × 4 ".
8. All the books and dictionaries will be published with ISBN number.
9. Matter will be submitted in soft copy (MS-Word file) through e-mail as and when it will be ready at our end.
10. Visva-Bharati will have the copyright of the books and dictionaries; however publication house may have its logo on the book showing as collaborative task with CFEL, Visva-Bharati.
11. Delivery of publications at Santiniketan is must within 50 days of submission of the relevant manuscript through e-mail.
12. 100 percent payment will be done through bank account only after timely delivery as well as satisfactory of the publications.
13. Having experience in linguistics related publication may be preferred.
14. Three set (1. Edited book, 2. Bibliography based books and 3. Dictionaries) of tender in one sealed envelope will be required till 11<sup>th</sup> November, 2020 (18:00 PM.) through speed post.

2. Apart from other applications in respect of the quality, standard, terms etc, the offer should specially clarify the points noted below, in the following order:
  - (i) Validity of offer
  - (ii) Central Sales Tax/VAT Sales Tax/Service Tax/GSTN
3. **Below are the explanations of the above points:**
