AN OVERVIEW OF THE WORKSHOP

The week-long Workshop is aimed at developing policy oriented research skills relating to different areas of Environmental and Natural Resource Economics. By the end of the Workshop, participants are expected to gain conceptual clarity and theoretical knowledge in these fields through a series of lectures which will be delivered by Resource Persons from following universities/institutions:

- University of Calcutta
- Jadavpur University
- Goa University
- TERI School of Advanced Studies (New Delhi)
- University of Burdwan
- Visva-Bharati

The success of the workshop would be reflected by participants' presentations towards the end of it. After the lecture series by eminent experts, participants are expected to present some research proposals that they would develop/refine during the workshop. A panel of experts (TBA) will be listening to the presentations and would provide comments and suggestions for their possible improvement.

WHO CAN APPLY

Applications are invited from research scholars and young faculty members from colleges and universities who wish to deepen their understanding in Environmental and Resource Economics and pursue policy oriented research in related fields. The intake capacity of the Workshop is around 25, who will be selected from the applicants on the basis of their CV and Statement of Purpose. Preference will be given to registered research scholars and young faculty in Economics and related disciplines from Indian universities/institutes.

HOW TO APPLY

Interested candidates may send their applications (**soft copies only**) with a brief academic CV and a brief Statement of Purpose (within 500 words) on or **before 2nd November, 2018**. Selected Participants will be intimated through e-mail by **7th November 2018**.

The registration fee for the Workshop is **INR 4000/- for faculty members and INR 1800/- for the research scholars**. The registration fee would cover registration kit, working lunch and tea and coffee for all workshop days. There will be no TA for attending the workshop. Participants have to arrange their own accommodation. The organizers may help the participants to book their accommodation on request.
