Quotations are invited for the following items by the Office of the Proctor, Visva-Bharati, Santiniketan -731235 for Closed Circuit Television Systems (CCTV) and other accessories as listed in the <u>Annexure I</u> within the due date and time mentioned above. Only one quotation from each bidder is invited.

Bidders are requested to go through all terms and conditions as well as the requirements of the bid stated below before finally uploading the bid onto the CPP Portal.

Please see that there are total 5 (five) annexures as Annexure I, Annexure II, Annexure III, Annexure IV and Anexure IV. Bidders are requested to go through all five annexures carefully.

TENDER TERMS AND CONDITIONS

1. All tenders will be scrutinized in three stages – (a) Pre Bid (b) Technical bid and (c) Financial bid. Pre Bid is a part of Technical Bid. The check list for Pre bid is listed in <u>Annexure III</u>. All vendors are requested to strictly submit the documents in sequence as per the checklist in <u>Annexure III</u> to qualify Pre bid. Any document not submitted according to <u>Annexure III</u> will lead to disqualification of the bid. Bidders are advised to fill up all columns of the <u>Annexure III</u> before uploading it to the portal.

2. The bidder must be an active Indian Manufacturer / Dealer / Distributor / Wholesaler for Supply of CCTV Camera and related accessories. For this, bidder has to provide latest purchase orders received from at least three different organizations for purchase and installation of CCTV system.

3. The bidder has to submit last year's audited balance sheet.

4. In case the bidder is not manufacturer, it has to submit valid Authority letter/Dealer or distributor/supplier/Wholesaler agreement/agency certificate issued by Original Manufacturer.

5. Bidder must submit a 'Integrity declaration' in the folliwing format

INTEGRITY DECLARATION

"We declare that M/s _____ has not been declared ineligible or black listed on charges of engaging in corrupt, fradulent, collusive or coercive practices or any failure/lapses of serious nature by Government of India or any other Government body in the past."

This is to be noted that bidder who does not comply/fail to submit the above declaration would be rejected. In any case, if such declaration is found to be false, the bidder would be blacklisted and would invite other legal provisions applicable.

6. In addition to points 2, 3, 4, and 5 above, the following essential documents must be submitted along with the bid.

7. A non-refundable application fee of Rs. 1000/- (Rs One thousand only) must be paid for every bid submitted. This fee may be paid as hard copy to 'Proctor, Visva-Bharati, Santiniketan 731235 with a forwarding letter referring the Tender reference and company for which such fee is being submitted. In case of Demand Draft, it should be in favour of the "Accounts Officer, Visva-Bharati University" payable at State Bank of India, Santiniketan.

8.Each bid must be accompanied by EMD of Rs. 20,000/- in the form of Demand Draftin favour of the"Accounts Officer, Visva-Bharati University" payable at State Bank of India, Santiniketan. A copy of the same must be uploaded along with the bid.

9. Those bidders who participated in the tender Ref. Memo no. P-25 (C) /27/ 2019-20 Date: 25.06.2019 should not deposit any application fee or EMD. However, they should upload the scan copy of the application fee and EMD in CPP Portal.

10.All tenders will be opened within 24 hours of closing the upload window. Bidders willing to participate in the bid opening should submit an authorization letter from the appropriate authority of the bidding firm beforehand to the tenderer. No separate invitation will be issued to bidders for this reason. All decisions will be published online through CPP Portal.

11. If necessary, bidders may be asked to give a presentation/demonstration of their quoted system before finalization of the bid. Demonstration of the camera system is compulsory for qualified bidders. Once order is received, the supply and installation must be completed within 30 days. No extension would be given without valid justification.

12. The bid, if submitted by OEM can not be transferred to its authorized partner/any other firm or vice versa.

13. All self attested copies of documents to be uploaded.

14. The bidder should have an active service wing and proof of providing service to the institution or similar institutions nearby should be attached with the bid.

15. The Office of the Proctor reserves the right to remove any item/items from the list without assigning any reasons.

16. The bidder must submit a compliance certificate in the form <u>Annexure IV</u>.

17. The price bid should be submitted strictly according to <u>Annexure V</u>.

18. The bids should clearly indicate the <u>unit price of each item</u> from serial no 1 to 23. For compatibility reason, total cost of items from serial no. 1 to 6 would be considered for price comparison.

19. The purchaser will not pay any charges against packing, forwarding, insurance, transporting the items to the destination, i.e. Visva-Bharati, Santiniketan.

20. Two years on site warranty essential for items from Serial no 1 to 6. For Serial no. 17, one year warranty is must.

21. The bidder should clearly indicate the delivery period and validity period of the bid from the date of receipt of order. The bidder shall have no right to revise the quote within the period of validity on the plea of fluctuations in the market rate. Normally the validity of the offer should be for a specified period of 90 days.

20. If awarded, a Performance Security, not more than 10% of the total final bid value would be acquired by the purchaser from the bidder.

21.All payments will be made after receipt, inspection, installation/testing of the tendered items as per the University procedure.

22. All damaged or unapproved goods shall be taken back at bidders risk and cost and the incidental expenditure thereupon shall be recovered from the concerned party.

24. The bidder shall have no right to place any pre condition for submitting bid for this NIT. Any conditions of the firm sent along with the bid, if any, shall not be binding on the purchaser.

25. In case the order is not executed within the stipulated period, the office of the Proctor will be at liberty to make purchases through other sources, and to forfeit the earnest money of the bidder.

26. The purchaser shall not be responsible for non-receipt/non-delivery of the documents due to postal delay or delivery at another address.

27. The purchaser is not liable to bear any cost incurred by the bidder in preparing the bid, attending the bid opening event, presentation, demonstration or any other relevant expenditure to the tender.

28. In case of any amendment by the purchaser to any part of the tender, the same will be notified in the website. The bidders may submit their response to the amended part separately within stipulated period.

29. Any grievances/issues should be addressed within 48 hrs from the opening of technical bid. Beyond this period, no grievances will be addressed. All grievances should be addressed to the tenderer only. Communication in any form to anyone other than bidder will be treated as canvassing and such bidder will be outrightly rejected without any notice.

30. The language of the bid is English.

31. Visva-Bharati reserves the right to impose liquidated damage as and when required; the rate of penalty will be at par with the same of the Govt. Of India's instruction.

32. Bank Commission where applicable will have to be borne by the supplier.

33. The tendrer reserves the right to cancel the tender without assigning any reason.

34. All disputes subject to "Bolpur, Birbhum, W.B. Jurisdiction" only.
