## VISVA-BHARATI EXAMINATION SECTION NOTIFICATION

Subject: Special arrangement for examination of ICCR scholars admitted in the session 2020-21

In connection with the subject cited above, the undersigned has been directed to bring it to the notice of all concerned that an online meeting held on 04.06.2021 at 4 p.m., attended by all Principals, Foreign Students Advisor, Registrar, Joint Registrar Examination, Joint Registrar Academic & Research and Deputy Registrar & CS to VC and chaired by Hon'ble Vice-Chancellor has resolved the following decisions subject to ratification by the Academic Council in due course:

During the academic session 2020-21, admissions of ICCR scholars was delayed inordinately and the students could be admitted only in the month of February/March 2021. Therefore, the students could not register themselves for the Semester I Examination 2020-2021 which was held in March 2021. To accommodate the students in the next semester without any break in their studies following decisions have been taken:

## A. For Kala Bhavana:

- Students of the B.F.A Foundation Course who need to decide their specialization towards the end of the second semester, for ICCR scholars, classes will be conducted of B.F.A Foundation Course during the summer vacation to compensate the loss of first semester.
- 2. Internal assessment marks of both first and second semesters and, the marks of semester-I play an important role in the selection process of specialization. So the semester-I examination shall be conducted before the semester-II examination.
- 3. The mark sheets of these students shall show as regular students and not as back candidates.
- 4. EVS and Tagore studies examinations shall be treated as their first chance and not as back candidates.
- 5. Special classes for the ICCR scholars, M.F.A.-Semester I Painting and Sculpture shall be conducted after the summer vacation to compensate the loss of first semester. And that will continue parallelly with the classes of second semester.
- 6. Kala Bhavana shall take necessary steps i.e., paper setting, moderation, conduct of examination evaluation and review(if any) for Foundation Course and semester I examination.

## B. For Shiksha Bhavana, Vidya Bhavana and Sangit Bhavana:

- 1. Examination of semester I for these students shall be taken with the Semester I examination of 2021-2022.
- 2. EVS and Tagore studies examinations shall be treated as their first chance and not as back candidates.
- 3. The mark sheets of these students shall show as regular students and not as back candidates.
- 4. Special classes for the ICCR scholars for semester I shall be conducted after the summer vacation to compensate the loss of first semester. And that will continue parallelly with the classes of second semester.

The above arrangement may be approved subject to ratification by the Academic Council in due course.
