In terms of the Resolution No. 1 of the meeting of the Karma-Samiti (Executive Council) of the University held on 03.07.2020 with regard to examinations as communicated by the Registrar, Visva-Bharati vide Reference No. G/K-10/1030720 dated 04.07.2020. The following decision of the Karma-Samiti as referred to above is notified:

"The Executive Council considered and approved the unanimous recommendation made in a meeting held on 02.07.2020 on the above matter, chaired by Vice-Chancellor in presence of all Directors, Principals, Heads of academic Departments/Centres and officials of the University for implementation".

Brief Note on the discussions held on 02.07.2020 at 4.00 P.M. in Bangladesh Bhavana with regard to Examinations, 2020

The following resolutions were adopted unanimously in view of the grave situation due to spread of Covid-19 Pandemic:

1. School Certificate Examination, 2020

- a. Since all the Practical Examinations and Bengali Paper-I(Theory Written) examination have already been held, marks obtained by the examinees will be taken into account in toto for preparation of results.
- b. For all other theory written papers/subjects, the following formula has been proposed: 80% on Internal Assessment + 20% of Viva-Voce(Online) be conducted by the Schools by a panel of examiners. The examination will be conducted tentatively within first week of August, 2020.
- c. Review of only Bengali Paper-I (Theory Written) will be allowed but not for other theory papers.
- 2. Terminal Semester Examinations 2020 of Undergraduate & Postgraduate Courses:

The following decisions have been taken unanimously -

a. No written or practical examinations shall be held and the result of such semester shall be prepared based on the following formulation:

Weightage:

- i) Internal Assessment 20% of the full marks of each paper/course.
- ii) Average of last two best semesters' score 60%
- iii) Dissertation/Project/Home Assignment will be conducted online by the Departments/Centres 20%. Dissertation/Project/Home Assignment need to be sent to the teacher concerned online by the examinees for evaluation after checking plagiarism as per UGC rule.
- iv) For the examinees of the Terminal semesters who have back paper(s)/course(s) in any intermediate Even Semester Examination only, the result of such intermediate semester(s) shall be prepared based on the following formulation:

Weightage:

- A. Internal Assessment 20% of the full marks of the back paper(s)/course(s).
- B. Average of the passed paper(s)/course(s) of that particular semester(s) -60%.
- C. Dissertation/Project/Home Assignment on the back paper(s)/course(s) will be conducted online by the Departments/Centres 20%.
 Dissertation/Project/Home Assignment need to be sent to the teacher concerned online by the examinees for evaluation.
- v) The online evaluation proposed as at 2(iii) & (iv) above need to be completed by the respective Department/Centre by 1st week of August 2020
- vi) For the papers/courses where there is no provision of Internal Assessment, the evaluation of such papers/courses may be made on the basis of the total marks submitted by the Head of the Department(s)/Centre(s) such as dissertation/project works/home assignments/credit seminar/RAWE etc.
- 3. Certificate, Foreign and other Casual Courses etc.: Scores/Grades/Marks will be given based on assignment/presentation (Online).
- 4. Only the Marksheet Fees of Rs. 50/- (Rupees fifty only) will be charged during online form fill up.
