## Tender for disposal of unserviceable and damaged items of Visva-Bharati, Santiniketan

### Description of lots:-

- 1. Lot 1:- Unused and damaged wooden furniture such as chair, table, bench, rack etc; scrap wooden furniture; plastic furniture
- Lot 2:- Damaged computer peripherals like CPU, monitor, UPS, printer; laboratory
  equipments like hot air oven, centrifuge, weighing balance; Office equipments like air
  conditioner, refrigerator, type writer, fan, water cooler etc
- Lot 3:- Unused and damaged steel furniture like almirah, table, chair, hospital bed, scrap steel furniture; heavy metal scrap like steel structure of shaw mill, iron overhead tank, collapsible gate

#### Terms and Conditions of the Tender

- 1. One tender form can be used for applying for one lot only.
- 2. Interested applicant has to fill up tender forms correctly as mentioned in the tender papers otherwise tender forms may be treated as cancelled. Rates are to be quoted both in figures & words.
- 3. Interested bidders are requested to inspect the temporary godowns of <a href="Estate Office">Estate Office</a>, Visva Bharati <a href="Newton">Newton Distanta</a> Distanta</a> Birbhum, West Bengal, Pin-731235 on 24/09/2015 to 26/09/2015 (within the office hours), accompanied by staff of Estate Office, Visva Bharati.
- 4. <u>Reserve Price</u>: Reserve price for Lot no A is Rs 2.52 lakh, Lot no B is Rs 8.55 lakh and Lot no C is Rs 9.07 lakh. Rates shall be submitted in multiples of Rs. 5000.00 (five thousand only) on and above the reserve price. If two or more bidders quote the same bid amount, Visva Bharati will conduct spot auction among such bidders only.
- Tenders on prescribed tender form (available at website) shall be submitted along with Demand Draft of Rs. 1000.00 (Rupees one thousand only) in favour of Deputy Registrar (Accounts), payable at Santiniketan, as application fee, failing which tenders will not be accepted.
- 6. <u>Bid Security Deposit</u>: Bid Security Deposit for Lot no A is Rs 25,200.00 (Rupees twenty-five thousand two hundred only), Lot no B is Rs 85,500.00 (Rupees eighty-five thousand five hundred only) and Lot no C is Rs 90,700.00 (Rupees ninety thousand seven hundred only). - 11. Each tender is to be accompanied by self-attested photo-copies of the above relevant papers. Tender forms without above credentials and Demand Drafts for application fees & Bid Security Money (as applicable for different lots) will be treated as cancelled.
- 12. The successful bidder of each lot shall deposit the accepted bid amount, after adjusting Bid Security Money, at the cash counter of Accounts office V.B. within 7 (seven) days from the date of receipt of acceptance-cum-work order letter from Visva Bharati. In case payments are not made in time, the above order will be automatically terminated without any prior intimation to the bidder(s) and his / their Bid Security Deposit will be forfeited.
- 13. Visva Bharati reserves the right to cancel any or all of the tenders without assigning any reason.

#### \* Terms and Conditions of the Contract

- The above materials will be disposed off, "as is where is basis", available in temporary godowns as mentioned above and elsewhere. List of items or any further details will not be provided or shown to the bidders under any circumstances.
- Successful bidders shall remove their specific lot / lots of scrap materials within seven working days of depositing the bid amount, failing which, the Bid Security Deposit submitted by the bidder will be forfeited and other actions will be initiated including resale of the goods in question at the risk and cost the defaulter.
- The bidder should make the site free from unserviceable / scrap materials, rubbish, tools plants before leaving the site
- 4. The successful bidder shall be responsible for payment of all taxes / charges / levies / fees etc which the Gov't or other authorities may charge and as may be applicable.
- 5. Judicial Jurisdiction: Bolpur / Suri Court and the Calcutta High Court.
- Disputes arising out of the contract shall be subject to the arbitration of a three member committee comprising one representative of bidder, one representative of the Visva Bharati and a senior lawyer / professional arbitrator agreed upon by both parties.
