Tender papers will be sold to the intending bidders on certification from the Competent Authority of the University, Visva-Bharati at Santiniketan against the application to be submitted by the contractor for purchase of tender paper in the prescribed form available from the office of the University Engineer / Professor In-Charge, (Engg. Dept).

Intending bidders are eligible for application provided he has credential of satisfactory completion of at least one similar works of value **not less than 60%** of the estimated cost in last 5 years ending previous day of last date of submission of bids.

For electrical work, the bidder should have valid electrical license with full time engagement of electrical supervisor holding supervisor certificates of S.C.C. Part 1, 2, 6A, 7A & 11 issued by the Licensing Board, Govt. of West Bengal / other States or equivalent National Supervisor Certificates of competency.

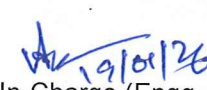
Bidders must submit the copies of valid **GST registration, credential of satisfactory completion of work, Electrical licenses** as specified, along with the application. The originals of those are to be shown as required.

The applicant who fulfills the stipulated conditions may obtain tender form together with (i) General Directions and Conditions of contract for works (ii) Standard Civil / Electrical Engineering Specifications from the **office of the University Engineer / Professor In-Charge, Visva-Bharati, Santiniketan** on all working days (**except Saturday, Sunday & Other holidays**) on payment of the sum as shown against the work in the cash section.

All Tender documents should be deposited in the letterbox in the Central Purchase Section.

Cash section remains open from 10:00 am to 1:30 pm on all working days except Saturday, Sunday & other holidays.

Bidders may attend themselves or send their authorized representative at the time of opening of tenders. Tender will remain valid for 90 (ninety) days from the date of opening. Full particulars about the procedure for depositing earnest money will be available in the tender documents.
