Terms and Conditions:

- 1) It is mandatory for the interested bidders to visit the above-mentioned godown and shops of Visva-Bharati Granthana Vibhaga at their own cost. They will inspect the stock within the below-mentioned date and time before quoting their rate including GST.
- 2) Three (03) working days i.e. 22.07.2024 (Monday) to 24.07.2024 (Wednesday) (up to 5 pm) is allotted for interested bidders for their visit with proper identity proof before submission of their best bid. Lowest bidder should provide sufficient manpower for completion of the work.

- 3) Submission of Tenders: Tenders should be submitted to the <u>Reception counter</u> from 29.07.2024 to 31.07.2024 (up to 5 pm). Sealed envelope <u>containing the hard copies of relevant Tender documents</u> should reach the office of the Director, Visva-Bharati Granthana Vibhaga, 6 A.J.C Bose Road, Kolkata 700017 within the stipulated time, failing which the Tender application will be treated as cancelled.
- 4) Lowest bidder will be called for verification of relevant documents such as Identity Proof, PAN Card, Income Tax Certificate, Income Tax Return, GST Registration, Experience Certificates (minimum three places of work preferably government sector) in original to the office of the Director, Visva-Bharati Granthana Vibhaga, 6 A.J.C Bose Road, Kolkata 700017 on 12.08.2024 (Monday) anytime within 5pm.
- 5) Self-attested copies of the following documents to be submitted along with Tender form:
 - a. Copy of GSTIN Registration Certificate
 - b. Copy of Valid trade license (relevant for the work)
 - c. Copy of Recent Income Tax Return and Service Tax return
 - d. Copy of PAN card
 - e. Details of experience in Stock Taking of Books and Periodicals (copy of supporting documents)
- 6) Bidders shall execute the work within the stipulated date i.e. 23.08.2024 (Friday) to 20.09.2024 (Friday) up to 5pm (except Saturday, Sunday and Visva-Bharati Holidays as notified in the Visva-Bharati website).
- 7) Lowest bidder has to submit Work Completion Report from 02.09.2024 (Monday) to 17.09.2024 (Tuesday) with actual reconciliation based on existing stock.
- 8) The Tenderer in its name or person, has been barred/blacklisted by the Central/State Govt./Dept. from participating in any work/project as on the date of bid, would not be eligible to submit Tender. In this connection, the Tenderer shall submit an acceptance as per **Annexure I.**
- **9)** Visva-Bharati reserves the right to cancel any or all the Tenders without assigning any reason.
- **10)** Disputes arising out of the contract shall be subject to the arbitration of a three-member committee comprising one representative of Bidder, one representative of the Visva-Bharati and a senior lawyer / professional arbitrator agreed upon by both parties.
- **11)** Legal dispute, if any, will be under the jurisdiction of the Hon'ble High Court of Calcutta.
