  - 1.2 Criteria of eligibility for submission of bid documents :

Intending bidders are eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed works specified below. These should be certified by officers not below the rank of Executive Engineer or equivalent.

One similar work/water supply operation & maintenance work/water supply projects consisting of laying of pipe lines/installation of pumps with all electrical accessories/Electrical installation/Electrical repair and maintenance work, of minimum value not less than Rs 5,19,461.00 or 2 nos. work of each not less than Rs 3,46,307.00, completed in last 5 years ending previous day of last date of submission of bids.

The bidder should have or may associate with other electrical contractor who has the valid electrical credential as stated under clause 1.2 above and valid electrical license with full time engagement of electrical supervisor holding supervisor certificates of S.C.C. part-1, 2, 6A, 7A & 11 issued by the Licensing Board, Government of West Bengal/Other States of equivalent National Supervisor Certificate of competency.

Electrical contractor/Agency not having the requisite credential for water supply projects/maintenance work need to co-opt with Agency, processing the requisite credential opted in the bid.

- Agreement shall be drawn with the successful bidders on prescribed Agreement Form. Bidders shall quote his rates as per various terms and conditions specified in the general directions and conditions of contract which will form part of the agreement.
