### Specifications for MIQE compliant Real Time PCR.

- Real time PCR with block of 96 x 0.2 ml tubes or plate to Run typical 0.2ml tubes, strips, and plates
- Should have a gradient capacity with Dynamic ramping.
- Should have a Detection of 2 or more different fluorescent reporters in the same tube without the use of ROX.
- Should be capable of Detecting FAM/Sybr Green, VIC, HEX, TET, CAL Fluor Gold 540 or more.
- The system should have a ramp rate of: 5°C per sec or better.
- Should have 6 Pellier Cooling & Heating for uniform temp control
