Guidelines for appointment of Vice-Principal of the Bhavanas / Vibhagas of the University.

1.	The Vice-Principal shall be appointed by the Upacharya according to seniority as
	far as possible among the Professors and Associate Professors of the concerned Bhavana in consultation with the Principal of the Bhavanas / Vibhagas.
	Shavaria in consultation with the Filholpar of the Bhavarias / Vibriagas.
2.	The tenure of Vice-Principal may be restricted to 2(two) years. However, it may be renewed for another term of 2(two) years, if so desired by the Principal.
3.	The Vice-Principal will perform such work as will be assigned by the Principal of Bhavana concerned.
4.	The Vice-Principal of the concerned Bhavana will look after the day to day work in absence of Principal. However, when the Principal will be on long leave or abroad, the Upacharya may appoint an acting Principal for that period only according to
	seniority.
5.	The Vice-Principal of Patha Bhavana and Siksha Satra shall be appointed by the Upacharya according to the seniority of Assistant Lecturers of concerned Bhavanas.
6.	There may be utmost two Vice-Principals in the Bhavana / Vibhaga.
7.	No remuneration / allowance shall be given for appointment of Vice-Principal, as per rule.
