OFFICE ORDER

The undersigned is to directed to communicate that the competent authority has been pleased to approve the following:

1. A Swimming Pool Management Committee (SPMC) has been formed with the following members:

a) Director, Studies, Educational Innovations and Rural Reconstruction - Prof Sabujkoli Sen - Chairperson

 b) Director, Physical Education, Sports, National Service and Student's Welfare - Dr (Col) Mani Mukut Mitra - Co-Chairperson

c) Head – Department of Physical Education –Prof Ashok Kumar Goon- Member

d) Proctor - Prof Samit Roy - Member

e) Deputy Director, Sports Board and Associate Professor – Dr Sudarsan Biswas – Project Manager and Member Secretary

The Swimming Pool Management Committee shall look into the policy matters pertaining to the activities of the swimming pool. The committee shall work out a fees structure in such a way that the swimming pool can function as a self financing unit for its operation and maint mance. SPMC will report to the Vice Chancellor and all matters relating to Finance will be placed before Finance Committee/ Executive Council of the University. The Security and Electricity charges pertaining to the swimming pool shall however continue to be met from the University budget. The Committee can co-opt one or two external members being national level swimmers/ officials.

- 2. Dr Sudarsan Biswas, Deputy Director, Sports Board and Associate Professor be entrusted with the following responsibilities in connection with operation of the Swimming Pool and its sustenance as a Self Financing Model:
 - a) Daily functioning and normal maintenance activities.
 - b) Organizing Inter University/ State Level/ National Level swimming competitions.

c) Organizing Special Coaching classes for swimming.

- d) Collection of subscription from all users and deposit to University account.
- e) Arrangement of funding/ sponsoring from external agencies for the development of the pool subject to the approval of the Vice Chancellor

- 3. The tournaments/ events may be organized during summer/ winter vacations so that accommodation may be made available to outstation participants (Girls/ Boys) in the hostels.
- 4. A sum of ₹20 lacs has been sanctioned on recoupment basis from XIIth Plan General Development Grant to the Swimming Pool Management Committee to release salary / all other pending payments relating to the swimming pool(except payments relating to NBCC)
- 5. The above shall be effective from 1st September 2015 and valid for one year from the date of issue of this Office Order.
