Every incumbents will be responsible for compilation, packing and transportation of art works for exhibition purposes abroad; supervising the activities of carpentary workshop; maintaining accession registers; organising seminars, lectures on art and art-related subjects; organising Children Art Sketch Club; publication of catalogues, brochures related to special exhibitions; display of Art works from the collection of Museum and change of display periodically; organising exhibitions; liaison work with Embassies, Custom authorities et al. in connection with the outgoing exhibitions. In addition, he/she will also assist the Curators in their specific areas of work.
