\rightarrow <u>Terms and Conditions of the Tender</u>:

- 1. Same as the terms and conditions displayed in MHRD e-Wizard Portal (<u>https://mhrd.euniwizarde.com</u>), Govt. of India.
- 2. It is mandatory for the interested bidders to visit the 3(three) nos. of godowns within the prescribeddate and Time before quoting their best bid price and obtain certificate of visit from the Competent Authority of Visva-Bharati Granthana Vibhaga. (The same is to be attached along with the Hard Copies of the relevant Tender documents).
- 3. The bidder should make his own transporation arrangements to remove the scrap and damaged books from the 3(three) nos. of temporary godowns as mentioned herein above within the stipulated time.
- 4. One working day & time (01.11.2021 from 11.00 a.m. 4.00 p.m.) is alloted for interested bidders for their visit to the Godowns mentioned above before submission of their best quote.
- 5. Officials of the Granthana Vibhaga will be present in the prescribed date and time to faciliate afruitful visit of the bidders enabling them to quote their best price undertaking due consideration of the shifting of scrapbooks from the godowns specified abovein.
- 6. Interested bidders has to fill up tender forms correctly as per guideline in the MHRD e-Wizard Portal any other tender form will not be accepted.

- 7. Interested bidders are supposed to bid their best price / rate in the MHRD e-Wizard Portal only.Financialbid will be open for those bidders who will essentially qualify in the technical bidas specified in the MHRD e-WizardPortal.
- 8. Reserve Pricewill not be shown in the NIT to obtain the best and highest price for the scrap books as mentioned herein.
- 9. Hard copy of the all relevant documents in (closed envelope) are needed to be forwarded to the office of the **Director, Granthana Vibhaga, 6, A.J.C Bose Road, Kolkata 700017**.
- 10. A demand draft of Rs. 1000.00 (Rupees one thousand only) payable to Deputy Registrar (Accounts), Visva-Bharati, Santiniketan is to be attached along with the hard copies of the Tender documents as application fee.
- 11. Bid Security Deposit: Bid Security Deposit for the whole Lot rested in three nos. of godowns as specified abovein is Rs. 10,000/- (Rupees ten thousand) only. Tenders shall also be accompanied by Bid Security Deposit as mentioned above in Demand Draft in favour of Deputy Registrar (Accounts), Visva-Bharati. Bid Security Deposit will be refunded to the unsuccessful bidders after completion of the tender process.
- 12. No interest will be paid over the Security Deposit to the unsuccesful bidders.
- 13. Submission of tenders: As per guideline of MHRD e-Wizard Portal. Closed envelope containing the hard copies of relevant tenderdocuments along with the Security Deposit should be reached to the office of the Director (Officiating), Visva-Bharati Granthana Vibhaga, 6, A.J.C Bose Road, Kolkata 700 017 within the stipulated timefailing to which the tender application will be treated as cancelled.
- Successful bidders after opening of technical bid will be called for verification of relevantdocuments such as Identity Proof, PAN Card, Income Tax Certificate, Income Tax Returns, Experience Certificate to the office of the Director (Officiating), Visva-Bharati Granthana Vibhaga, 6, A.J.CBose Road, Kolkata – 700 017 within three consecutive working days as specified herein above.
- 15. **Opening of Tender: Tenders may be opened on at 15.11.2021 about 11 a.m.**
- 16. **Essential eligibility criteria for Bidders**: Bidders having experience in similar works in a Govt./ Private organization (copy of theWork Order / Completion Certificate to be submitted)
- 17. Documents to be submitted along with tender form
 - a. Service Tax and VAT Registration
 - b. Income Tax clearance upto F.Y. **2020-2021**
 - c. Valid trade license (relevant for the work)
 - d. Recent Income Tax and Service Tax return
 - e. PAN No.

- 18. Each tender is to be accompanied by self-attested photocopies of the above relevantpapers. Tender forms without above credentials and Demand Drafts for application fees &Bid SecurityMoney (as mentioned abovein) will be treated as cancelled.
- 19. The successful bidder shall deposit the accepted bid amount, after adjusting BidSecurityMoney, at the cash counter of Accounts office V.B. within 7(Seven) days from the dateofreceipt of acceptance-cum-work order letter from Visva-Bharati. In case payments are not made in time, the above order will be automatically terminated without any prior intimation to the bidder(s) and his / their Bid Security Deposit will be forfeited.
- 20. Bidders shall execute the work order within the stipulated time as mentioned in the NIT.
- 21. Visva-Bharati reserves the right to cancel any or all of the tenders without assigning anyreason.


Terms and Conditions of the Contract:

- 1. The above materials will be disposed off, "as is where is basis", available in temporary godowns as mentioned above. List of items or any further details will not be provided orshown to the bidders under any circumstances.
- 2. Successful bidders shall remove the scrap books within seven workingdays from the date of depositing the bid amount, failing which, the Bid Security Deposit submitted by thebidder will be forfeited and other actions will be initiated including resale of the goods inquestion at the risk and cost the defaulter.
- 3. The bidder should make the site free from unserviceable / scrap materials, rubbish, tools plantsbefore leaving the site.
- 4. The successful bidder shall be responsible for payment of all taxes / charges / levies / fees etc.which the Government or other authorities may charge and as may be applicable.
- 5. Judicial Jurisdiction: Bolpur / Suri Court, Metropolitan Court, Kolkata and the Calcutta High Court.
- 6. Disputers arising out of the contract shall be subject to the arbitration of a three membercommittee comprising one representative of bidder, one representative of the Visva-Bharati and a senior lawyer / professional arbitrator agreed upon by both parties.
