Subject: Intimation regarding Enumeration Programme of Census 2027 and request for facilitation of free & fare access to Visva-Bharati Campus, including the UNESCO World Heritage Site area and adjoining areas.

Sir/Madam,

In exercise of the powers conferred upon me under Sub-Section (4) of Section 4 of the Census Act 1948 (37 of 1948) read with Rule 3 of Census Rules, 1990 and the powers delegated by the State Government of West Bengal vide letter/ Notification No 617-Home/O/CEN-02/2025, Enumeration Programme for the Houselisting and Housing Census 2027 (Phase – I) for Houselisting Block No 0041, 0042, 0043, 0044, 0045, 0093, 0094, 0335, is scheduled to be undertaken on as per the programme [16/08/2026 to 14/09/2026 (Phase-I) & 01/02/2027 to 28/08/2027 (Phase-II)], instructions and statutory provisions issued by the Office of the Registrar General & Census Commissioner, India, Ministry of Home Affairs, Government of India.

In this connection, the enumeration and related field activities are required to be conducted within the jurisdiction of Visva-Bharati, Santiniketan-Sriniketan, as well as the adjoining areas falling within the assigned enumeration jurisdiction. The field personnel engaged in the Census work will be required to visit residential areas of the Campus, institutional and other premises for verification, enumeration and collection of information in accordance with the prescribed Census instructions and schedule.

It is therefore requested that the following arrangements may kindly be facilitated by Visva-Bharati authorities during the Census 2027 enumeration programme (Phase – I & II)

1. Free and unhindered access may kindly be provided to the authorised Census Enumerators, Supervisors and other Census functionaries to the concerned areas of the Visva-Bharati campus for carrying out Census duties.
2. Necessary access may particularly be facilitated in respect of the UNESCO declared World Heritage Site/heritage campus area of Visva-Bharati, including the heritage buildings, residences, institutional premises and other notified/identified heritage areas, wherever such premises fall within the assigned enumeration blocks.
3. Security personnel, gate authorities, administrative offices and concerned custodians of buildings may kindly be advised to permit authorised Census personnel to enter the premises on production of their official Census identity cards/authorisation, subject to the applicable Census instructions and security protocols.
4. Similar access may kindly be facilitated to the adjoining areas, residential quarters, hostels, guest houses, offices, academic establishments, service establishments and other premises falling within the Census enumeration jurisdiction of Visva-Bharati.

5. The concerned Bhavana/Department/Office/Section/Administrative Unit may kindly extend necessary cooperation to the Census personnel and provide reasonable assistance for identification of premises, households, institutional establishments and other enumeration units.
6. Where access to any restricted or heritage-sensitive premises is subject to special security, conservation or administrative procedures, suitable arrangements may kindly be made in advance so that the Census work can be completed without interruption and within the prescribed schedule.
7. The concerned authorities may kindly ensure that Census personnel are not unnecessarily prevented or delayed from performing their assigned statutory duties, while maintaining all applicable security, heritage conservation and institutional protocols.

The above request is being made in view of the statutory nature of Census operations and the requirement that all eligible persons and establishments falling within the assigned jurisdiction are duly covered during the enumeration process. The Census personnel will perform their duties strictly in accordance with the instructions issued by the competent Census authorities and will carry valid identification/authorisation issued for the purpose.

It is, therefore, requested that a suitable Office Order/Administrative Instruction may kindly be issued to all concerned authorities, including security personnel, gate personnel, Bhavana/Department Heads, residential quarters/hostel authorities and custodians of heritage buildings, informing them about the Census 2027 enumeration programme and directing them to extend necessary cooperation and facilitate free and authorised access to Census personnel.

Your kind cooperation in this national statutory exercise will greatly facilitate the smooth, comprehensive and timely completion of Census 2027 enumeration within Visva-Bharati and its adjoining areas, including the UNESCO declared World Heritage/heritage campus area.

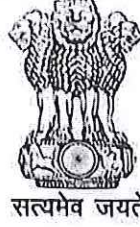
