For electrical work, the bidder should have valid electrical license with full time engagement of electrical supervisor holding supervisor certificates of S.C.C. Part 1, 2, 6A, 7A & 11 issued by the Licensing Board, Govt. of West Bengal / other States or equivalent National Supervisor Certificates of competency.

Bidders must submit the copies of valid GST registration, credential of satisfactory completion of work, Electrical licenses as specified, along with the application. The originals of those are to be shown as required.
