Candidates shall have to secure 6 credit points out of 12 credit points (total-300 marks) of (55% marks) in final aggregate (total-150 marks). Qualifying marks in each of the above courses-50% marks. Course work duration- 6 moths and per paper 4 hours. One (1) credit is equivalent to 25 (Twenty five) marks.
