### **NOTIFICATION**

#### **Staff Vehicle-Parking Stickers**

This is for information of all staff and employees of Visva-Bharati that vehicles – two- and four-wheelers (private motorcycles/scooters/motor cars, including electric vehicles, etc) – belonging to staff/employees with valid Visva-Bharati official IDs which are used by staff and employees during their official work in Santiniketan and Sriniketan must display a formal Visva-Bharati sticker. This will enable smooth and hassle-free parking of vehicles within the university premises.

An employee shall be issued a maximum of one four-wheeled vehicle and one two-wheeledvehicle pass. Two forms must be filled for two different (2 or 4) wheeled vehicles.

The pass/s shall be <u>valid till 31.12.2027</u>, or, <u>till the date of superannuation</u> of the employee, whichever is earlier.

The following documents are required for the processing and issuing of parking stickers:

- 1. Copies of Visva-Bharati Employee ID (both sides)
- 2. Copies of Vehicle Registration Certificate (RC) of vehicle/s (both sides)
- 3. Self-declaration form (ONLY in case the vehicle/s in use is not registered under thename of the staff/employee; kindly note: that only vehicles registered under thename of father/mother, spouse (husband/wife), and son/daughter of the employeewill be considered)

All permanent employees of Visva-Bharati who have not filled the Google Form earlier for issuance of Vehicle Parking Stickers are hereby informed that they can now fill in the form ONLINE ONLY from 17.12.2025, 03.00 PM onwards.

Staff are requested to complete the form within the stipulated time (31.12.2025).

NO OFF-LINE submission of documents will be required. All process is ONLINE only.
