Abstract Submission Period: 17th August 2026 to 17th September 2026

Submission Requirements

- **Abstract Language:** English, Bengali, Hindi
- **Abstract Length:** 250 – 300 words.
- **Keywords:** 4 – 5 keywords (to be placed above the abstract).
- **Bio-Note:** 100 – 150 words, including your institutional affiliation (to be placed below the title).

- **Citation style: MLA**
- **Original & Unpublished work**
- **Standard Plagiarism & AI check to be applied**

Formatting Guidelines

- **Font Style:** Times New Roman (English) / Kalpurush (Bengali) / Kokila (Hindi)
- **Title Formatting:** 14 pt, Bold
- **Bio-Note Formatting:** 12 pt, Bold
- **Abstract Body Formatting:** 12 pt
- **Line Spacing:** 1.5 spacing

Registration (after selection of the abstract)

- **For registration form link will be sent with the acceptance letter through mail.**
- **Registration Amount (Both Online & Offline):** Student – **1000/-**
Scholars and Researchers – **1500/-**
Faculty members – **2000/-**

- Abstract will be sent through mail. Write down your contact details on the mail body.
