Resolutions:

Academic Audit Committee

1. The Principals of the all Bhavanas may be authorized to form the Academic Audit Committee for the Bhavana concerned with one/two expert-members. After collection of the names, the proposed names may be sent to the Chairman, IQAC for approval to proceed further, in this regard and for submission of report to IQAC same date line as one above, may be followed.
