Prof. R.P Mishra chaired the meeting.

The Chairman IQAC welcomed the members of IQAC present in the meeting.

The Chairman briefly reported about his presentation before the visiting Peer Revie Team of NAAC to the University. The NAAC team conveyed their satisfaction about CAS related activities of IQAC and exhorted to take up pro-active steps for spread quality culture in the campus.

The Chairman apprised the members of that quality-related activities could be initiatif there is improvement in the prevailing fund allocation to the IQAC.


After initial remarks, a detailed agenda-wise discussion led to the following resolutions / recommendations:-

- 1. The members expressed their concern about unsustainable financial support f implementation of the tasks and unanimously agreed that a proposal seeking funds continue the activities of the IQAC for the rest of the XII plan period be prepared as sent to the administration for consideration. The members also recommended that, view of the NAAC team's suggestion, the proposal should include fund provision f holding seminar / workshop. It was felt that IQAC office is mostly engaged in the continuous of promotions & recruitment and hence, members strongly recommend that the payments towards the office support staffs should be met from the Registrar Office (Establishment). This is also a matter of financial convenience.
- 2. Papers laid on the table: The letters and correspondences received from UGC and t reply sent to the UGC for the information of the members.
- 3. The members were informed about status of processing of applications by vario Bhavanas.
- 4. The following applications of CAS are related issues along with the notings Registrar's office were placed for consideration of the members. After caref discussion and scrutiny, the following decisions were arrived at:
 - i) The post-facto note of Head/ Silpa Sadana on the recommendation sheet of Sn Shyamali Sengupta may be ignored as i) it was initially forwarded as recommended by the HOD herself ii) during evaluation period the members h unanimously recommended the case of Shymali Sengupta. It is recommended that h papers may be sent to the Establishment for consideration and approval of tl Upacharya.
 - ii) The Chairman is authorized to discuss the case of Dr. Eshita Chakraborty with tl Establishment to sort out the issue.
 - iii) Apropos the application of Prof. Bhabatosh Mandal, Prof. Subrata Mandal at Prof. Swapan Kr. Chandra, members noted the relevant UGC guidelines: "If the candidate does not succeed in the first assessment but succeeds in an eventual assessment, his/her promotion will be deemed to be from the later date." However, given the fact that there was an inordinate delay in holding the first interview (in or case almost four years after the due date), the application of the candidates may be placed for sympathetic consideration of the administration.

- iv) The members felt that application of Dr Biswajit Pandey can't be recommended for consideration as the UGC guidelines stipulates that the CAS promotion shall be effective after the incumbent fulfills the requirements of Orientation and Refersher courses.
- v) Perusing the case of Sri Pulak Patra, it was noted that calculation of the API score should be done by including the additional publication (within due date) and, accordingly, eligibility of the incumbent for CAS from stage II to Stage III is recommended with effect from 14.02.2011. The Registrar's Office (establishment) may be requested to process the application accordingly.

The meeting ended with a vote of thanks to the Chair.
