Concept Note

India's musical heritage is a complex tapestry woven from centuries of diverse cultural traditions, regional influences, and evolving styles. Gurudev Rabindranath Tagore, the founder of Visva Bharati, thinking much ahead of his times, emphasized on an inter-disciplinary approach towards art practice. Teaching of music and visual arts were always an integral part of his pedagogic vision of a comprehensive education system. Sangit Bhavana, Institute of Music, Dance and Drama was founded in 1919 together with Kala Bhavana (presently, the Institute of Fine Arts) as an integrated programme; it was later established as an independent entity in 1933. The institution has developed as a pre-eminent centre for specialized training in Hindustani classical music (vocal and instrumental) and different forms of Dance, Rabindra Sangit and Drama. Having completed 100 years of its establishment, Visva-Bharati, Santiniketan was declared as the World Heritage Site by UNESCO in 2023.

In continuation of this rich legacy, the Department of Hindustani Classical Music, Sangit Bhavana, Visva-Bharati is organizing a two-day International Seminar that aims to explore the multifaceted nature of Indian music, from classical forms to folk traditions, and its position in the global cultural landscape. Through a series of presentations and discussions, we will delve into various subtopics that highlight the depth and breadth of Indian music, its pedagogy, and its philosophical underpinnings.
