Paper–I HISTORICAL METHOD & RESEARCH METHODOLOGY

MODULE 1: Source Materials of Maratha History

Maratha History began in the seventeenth century with the foundation of the Maratha Swarajya by Chhatrapati Shivaji. The documents of the Maratha Empire have been well-preserved allowing the modern researcher a unique experience of consulting first-hand source materials composed in different languages. MODULE 2: Environmental History of India—Nineteenth and Twentieth Centuries

MODULE 3: Gender Studies

MODULE 8: Tourism in India: Planning, Practice and Scope of Research

Tourism has emerged to be a revolutionising phenomenon, outpacing the manufacturing and extractive industries as a catalyst of the development process. Thematically, it will discuss such issues as—public health in colonial India and institutions related to it; race as a category in medical thought and practice; interrelated themes of gender, morality, hunger and diet; Indian medical traditions; epidemics and social dislocation. Within these overarching themes, special attention would be paid to the diverse worlds of white women and women of colour; childbirth, motherhood and midwifery; female sexuality and the politics of diet and hunger; famines; and so on.
